Strategic location at Port Westward Industrial Park



Global access to ultra-low-carbon feedstocks (e.g. fish grease, used cooking oil, animal tallow)



750 million gallons of renewable diesel per year (equivalent of Oregon's fossil diesel demand)



Expected to be operational in 2028

Green Union Jobs for Oregon

- 3,500 family-wage, green jobs during construction
- 240 long-term, green jobs during operation
- MOUs with Columbia Pacific Building Trades
 Council and Pacific Northwest Regional Council of Carpenters for construction
- Neutrality agreement for the facility, allowing for union organizing should employees choose
- · Strong support from Oregon AFL-CIO

Healthy Communities & Ecosystems

- Reduces carbon emissions by up to 80%
 Equivalent to taking 1 million cars off the road every year
- Decreases black carbon (soot) that falls on snowpack, creating cleaner waterways and combatting drought
- Improves the quality of life and health of those who work and live around diesel equipment

Supporting Oregon's Climate Goals



Oregon's Climate Protection Plan requires fuel suppliers to reduce GHG emissions by 50% by 2035 and by 90% by 2050



TriMet, Lane County, Salem and Eugene transit services all now only use renewable diesel in their buses and need reliable sources for their fleets



Metro's Climate Smart Strategy advocates for low-carbon fuels like renewable diesel



Port of Portland supports greater adoption of SAF and RD at its facilities
